Intimation through e-mail and SMS about the Pre-Employment Medical Examination shall be sent to individual candidates.

The final selection/appointment would be subject to satisfactory medical report and verification of certificates pertaining to age, qualification, caste certificate/ income and asset certificate (in case of reserved category candidates), disability certificate (in case of PwBD candidates), documents in support of Ex-Servicemen status and any other applicable documents/testimonials etc. No travelling expenses will be paid for medical examination.

Please note that in case any candidate does not report for Pre-employment Medical Examination within 21<sup>st</sup> January 2026, their candidature would automatically stand cancelled and it will be assumed that they are not interested in the Employment. No further correspondence in this regard will be entertained.

Kindly note that the Recruitment Exercise is subject to order(s)/direction(s), if any, issued by Hon'ble Courts having competent jurisdiction in any case/s subsisting as on date.
